DESCRIPTION


NEC's NX7312UA is a 1310 nm Multiple Quantum Well (MQW) structured Fabry-Perot (FP) laser diode TOSA (transmitter optical subassembly) with InGaAs monitor PIN-PD in a receptacle type package designed for SFF/SFP transceiver with LC duplex receptacle. This device is ideal for Synchronous Digital Hierarchy (SDH) systems, short haul STM-1 (S-S.1) and short haul STM-4 (S-4.1), ITU-T recommendations, and SONET OC-3(IR) and OC-12(IR).





TYPICAL PERFORMANCE CURVES (Tc = 25°C)






FORWARD VOLTAGE vs. FORWARD CURRENT




OUTLINE DIMENSIONS (Units in mm)
